Background

To find and treat all people with TB and to achieve the World Health Organization (WHO) End TB Strategy¹ targets countries must abandon the passive, top-down disease programmes of the past and adopt a radical new approach. According to the Stop TB Partnership (STP) and as articulated in the Global Plan to End TB this approach should strive for equity and address the structural, social, socioeconomic, human rights, (R) and gender (G) drivers of the disease and ensure the meaningful engagement of empowered people and affected communities (C) in the TB response. This Community, Rights and Gender (CRG) approach aligns with the WHO End TB Strategy that promotes the protection and promotion of human rights, ethics and equity and the latest articulation of a rights-based approach to TB in the UN Political Declaration on TB and subsequent progress reports, including A Deadly Divide; TB Commitments Vs TB Realities.

Community-led monitoring (CLM) is an important element of a CRG approach to TB. To support national CLM efforts Stop TB Partnership developed a CLM conceptual and implementation framework and digital platform to enhance it. It is called OneImpact CLM.

OneImpact CLM empowers people affected by TB to access health and support services, claim their rights, and identify and reduce stigma. Through an innovative mobile application, OneImpact CLM encourages and facilitates the participation of people affected by TB in all aspects of TB programming to activate a human rights-based, people-centered response. In doing so, OneImpact CLM combats the central challenges in the TB response at the individual and community levels, while generating essential information in the form of digital data to better understand and combat them at the programmatic level, to end TB.

OneImpact *Conceptual and Implementation Framework* and *Digital Platform* were developed in collaboration and partnership with Stop TB Partnership Tajikistan, Eastern Africa National Networks of AIDS and Health Service Organizations (EANNASO) Tanzania, Khmer HIV/AIDS NGO Alliance (KHANA) Cambodia, Lembaga Kesehatan Nahdlatul Ulama (LKNU) Indonesia, TBpeople Ukraine, Associacao Mocambicana para a Ajuda de Desenvolvimento de Povo para Povo (ADPP) Mozambique, Club des Amis Damien (CAD) DR Congo, TBpeople Ukraine, Copperbelt Health Education Project (CHEP) Zambia, African Coalition on TB (ACT), Activists Coalition on TB, Asia Pacific (ACT! AP) hosted by APCASO, TBpeople, Global Coalition of TB Activists (GCTA), Dynamique de la Réponse d'Afrique Francophone contre la Tuberculose (DRAF TB), Treatment Action Group (TAG) USA.
